2. <u>Hot Topics! Neighborhoods, Other Comm & Staff:</u>

<u>Grant Park, Ron Laster & Ken Peterson</u>: April board elections cancelled, neighborhood cleanup cancelled, organized neighbors help system, newsletter updated to reflect changes due to COVID-19.

Roseway, Catherine Wilson: nothing new to report.

Rose City Park, Jay Griffith: last meeting held May 5, 2020 was held via Zoom and on YouTube, next meeting on May 26, 2020 will also be on Zoom, YouTube and the web; board elections moved to a meeting in the fall; discussed presentation of Overhead Continuous Decent Approach issue, Oregon National Guard supports, will move forward with online neighborhood survey and discuss at a future meeting.

<u>Cully, Claire Alyea:</u> last meeting held online; newsletter editor stepped down, looking for a replacement; board elections postponed; neighborhood cleanups are cancelled so they may not have funds to continue the newsletter.
